Minutes of the Meeting of Ireby and Uldale Parish Council held at the WI Hall, Ireby on Tuesday 2nd January, 2024 commencing at 7.30 p.m.

The Chairman opened the meeting and wished everyone a Happy New Year.

74 APOLOGIES FOR ABSENCE

An apology for absence was received from Cllr. J. Logan. The reason for absence was noted and accepted.

75 MINUTES – 7 NOVEMBER 2023

The minutes of the meeting held on 7th November, 2023 were agreed as a correct record and were signed by the Chair.

76 DECLARATIONS OF INTEREST

Cllr Forrest declared an interest in item 11 on the agenda Adoption of Defibrillators. No requests for dispensations were received

77 REPORTS

- (a) Cumbria Police: The newsletter for the Cockermouth/Keswick area had been circulated.
- (b) Cumberland Councillor Cllr J. Perry reported on the following:

"Local Government Boundary Commission review

We are going to undergo another boundary review. We have had a presentation from the LGBC on their planned review of Cumberland ward boundaries, which will be in place in time for the next Cumberland elections. It will be taken in parts. First they will review the number of councillors, they will liaise with the Council on this, and will make a decision by October of this year on whether to increase the number or not. When that has been decided, there will be a consultation on ward boundaries/number of councillors per ward Nov 24-Feb25. They will draft proposals and be a full public consultation May-August 25. In October 25 they will make their final recommendations which cannot be altered.

I am pretty certain that the number of councillors will increase as it is difficult to fill places on all the committees and outside bodies, as well as the workload associated with one councillor per large ward. However, it is completely up in the air how this will be managed – it could mean smaller wards (based on number of voters, not size of area) or it could be two or three councillor wards, or some combination of the two. The aim, as always, is to equalise numbers of voters. Obviously cost will also be an issue.

Community Panel news

At our last Community Partnership meeting – December - we decided to advertise for up to three co-opted members to help us deliver our community investment plan. The posts are voluntary and non-voting but travelling expenses will be paid. The adverts will be placed this month, so if you are interested or know someone who might be, let me know and I can let everyone know when the adverts go out.

We also gave out grants details of which are on the council website in the Lakes to Sea section but include a grant to Bothel village Hall for a power wall battery storage system to use with solar panels. We have about 25,000 left in the pot and only one more meeting before the end of the financial year.

The next network meeting is to be held this month but we have no details of the form it will take or where it will be held as yet"

Cllr Perry also reported that she had received a response from Highways advising that a review of speed limits will not be undertaken for three years. A request has been put forward to Cumberland Council for the timetable for the review to be revised as there are currently 50 applications outstanding in the former Allerdale area.

Cllr Perry advised that there is a guide to developing an emergency plan on ACT's website.

The meeting was adjourned to allow members of the public to raise matters relating to items on the agenda.

78 PUBLIC PARTICIPATION

The following matter was raised:

Withdrawal of Rural Bus Service – A resident in attendance advised they had written to Mark Jenkinson MP regarding the suspension of the Stagecoach 73 service during the winter months. A response had been received from Stagecoach to advise that the service will be reviewed in 2024. It was suggested that the Parish Council contact the MP and Cumberland Council requesting that the service be considered under the Bus Service Improvement Plan.

The meeting was re-convened.
