1 ELECTION OF CHAIR FOR COUNCIL YEAR 2023/2024

Nominations were invited for the election of Chair. It was proposed by ClIr E. Alexander and seconded by ClIr G. Moore that ClIr K. Bridges be re-elected Chair. No other nominations were received. RESOLVED that ClIr K. Bridges be re-elected Chair for the ensuing year.

2 TO RECEIVE THE CHAIR'S DECLARATION OF ACCEPTANCE OF OFFICE

Cllr K. Bridges had agreed to accept the Chairmanship if nominated. Arrangements will be made for the declaration of acceptance of office to be signed.

3 APPOINTMENT OF VICE-CHAIR FOR COUNCIL YEAR 2023/24

A proposal was received and seconded that Cllr G. Moore be re-appointed Vice Chair. RESOLVED that Cllr G. Moore be re-appointed Vice Chair for council year 2023/24.

4 APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllr K. Bridges and Cllr P. Crooks. The reason for absence was noted and accepted.

5 MINUTES – 7 MARCH 2023

The minutes of the meeting held on 7th March, 2023 were agreed as a correct record and were signed by the Chair.

6 DECLARATIONS OF INTEREST

Members were provided with a register of pecuniary and disclosable interests form from Cumberland Council for completion.

Cllr J. Logan and Cllr A. Forrest declared an interest in item 16(d) on the agenda Donation request towards the valuation of the pub by the Plunkett Foundation.

Cllr. A. Forrest declared an interest in item 15 on the agenda Adoption of the defibrillators. Cllr. J. Logan declared an interest in item 16(a) on the agenda maintenance equipment for the school.

7 POLICE REPORT

The newsletter for the Wigton/Aspatria/Silloth area had been circulated prior to the meeting.

8 PUBLIC PARTICIPATION

Further to Min Ref 81 further information was provided and a paper from the Chair of Boltons, Ireby & Uldale First Responders had been circulated to members regarding the adoption of the defibrillators in Ireby and Uldale.

9 MATTERS ARISING FROM THE MEETING ON 7 MARCH 2023

Emergency Planning (Min Ref 87) – Cllr Perry reported that a parish emergency plan should be more specific to the local community. The plan should be accessible and ensure that residents are aware of what to do in the case of an emergency.

United Utilities Drop-in Sessions (Min Ref 90) – Cllr Perry reported she had approached United Utilities to enquire if the drop-in session in September regarding the Chapel House and Overwater Reservoir De-commission project could be held in Ireby. Cllr Perry advised she had not received a response but will speak to UU on 15th June at the drop-in session at Loweswater when information on the proposals for Crummock will be available.

Cllr Perry also reported that Cumberland Council had now set up Community Panels. Bothel and Wharrels will fall within the Lakes to Sea area panel. The Panels will draw up a Community Investment Plan to identify priority areas, priorities, actions and investments and has a budget of £60,000.

10 ANNUAL INSURANCE

The renewal documentation had been received from BHIB Limited at a renewal premium of £366.98. It was agreed that the policy with BHIB provides adequate cover for the parish council's requirements. RESOLVED to renew the policy with BHIB Limited.

- (iv) Certificate of Exemption Members resolved that the Certificate of Exemption should be signed by the Chairman and Clerk certifying that the Parish Council is exempt from a limited assurance review and during the financial year 2022/23 the gross income for the year or gross annual expenditure for the year did not exceed £25,000.

15 ADOPTION OF DEFIBRILLATORS IN IREBY AND ULDALE

The proposals for the adoption of the defibrillators had been circulated prior to the meeting.

Each defibrillator has a guardian who checks the box once a week and sends an online report to the Ambulance Service confirming that it is still functioning. The ongoing costs include an electricity supply which is covered by the Globe Hall in Ireby and will need to be reviewed now that the Snooty Fox in Uldale has closed and routine replacement of the battery and pads. The BIUFR are proposing to transfer each machine by September with £300 to cover the first few years running costs.

Cllr Cockburn proposed, seconded by Cllr Alexander therefore RESOLVED that the defibrillators in Ireby and Uldale be adopted by the Parish Council.

16 DONATION REQUESTS

- (a) Maintenance equipment for the School. Members agreed that any request should be submitted to the council from the school and will be considered once received.
- (b) Ireby PCC Grass cutting at Ireby Churchyard Members agreed to defer this item. The request will be considered alongside the request for grass cutting at Udale Church once received.
- (c) Uldale DCC Grass cutting at Uldale Churchyard The request for a donation towards the grass cutting is still awaited.

(d) Valuation of Emilys Black Lion by the Plunkett Foundation Members considered the costs involved if the Plunkett Foundation were to carry out a valuation of the pub. It was noted that the membership fee of £200 had already been paid. Cllr W. Hall proposed that £900 be granted towards the valuation costs, this was seconded by Cllr R. Cockburn. RESOLVED that £900 be granted.

17 ELECTION OF PARISH MEMBER TO LAKE DISTRICT NATIONAL PARK AUTHORITY

Members noted that the term of appointment of the parish members on the Lake District National Park Authority from the North, East and West distinctive areas come to an end in May 2023. The election of new parish members (who will be recommended to the Secretary of State for appointment) will be arranged by the CALC. The deadline for receipt of completed nomination papers is 26th May. Members resolved not to put forward a nomination from the council.
