### **78 MINUTES – 3 JANUARY 2023**

The minutes of the meeting held on 3<sup>rd</sup> January, 2023 were agreed as a correct record and were signed by the Chair.

# 79 DECLARATIONS OF INTEREST

Cllr G. Moore declared an interest in item 8(c) on the agenda (S38 application Caldbeck and Uldale Commons)

# 81 PUBLIC PARTICIPATION

Mike Muir, Chair of Boltons, Ireby and Uldale First Responders was in attendance to provide members with an update on the First Responders.

At the First Responders AGM, it had been agreed that the time had come to disband. Currently there are no active First Responders, although 2 people had come forward as potential volunteers. There are 2 Public Access Defibrillators on the wall in Ireby and Uldale. The First Responders are looking at who might look after them if they do disband. They are both up to date and should not cost anything for the foreseeable future. The First Responders have funds in their account that could be transferred with the boxes to cover future costs. Both machines have a current "Guardian" or a person who checks them every week and reports back to the North West Ambulance Service and those Guardians will continue in their roles.

The Parish Council was asked to consider taking on the responsibility for the defibrillators in Ireby and Uldale. This will be added to the agenda for the next parish council meeting.

The use/abuse of the Ireby noticeboard was raised once again. Members agreed to remind users/residents via the noticeboard and Binsey Link of the protocol for the use of the parish noticeboards that was agreed by members at the July 2022 meeting. The Chair advised that there had been no problems reported with the Uldale notice board.

An update was provided regarding the request for a donation for maintenance equipment or insurance cover. Members were advised that it had been established that Cumbria County Council Countryside Access are responsible for maintaining the path and are willing to restore it and carry out maintenance once a year.

Mike Muir left the meeting.

# 82 MATTERS ARISING FROM THE MEETING ON 3 JANUARY 2023

The Clerk reported that the cheque payable to CWB Forestry had been refused by the payee's bank. This was confirmed on the bank statement from Barclays. A replacement cheque had been requested.

A complaint had been received that the cherry tree at the top of the whent is getting too big with a lot of ivy growing on the trunk. A parish member in attendance agreed to look at the tree and ascertain if the ivy can be removed.

# 85 HIGHWAYS/HIGHWAY MAINTENANCE

(a) Highway issues in the Parish

The pot hole on the main street in Ireby had been repaired. The gravel on Snittlegarth lonning had been removed

The street light at Binsey Farm had been fixed

Drains had been jetted and are now working properly following two floods near Prior Hall lonning end.

Tree roots causing damage to the highway – Highways had attended the area to investigate the issue but unfortunately it does not meet the investigatory levels therefore no works are required at this time. The location will continue to be inspected and if the problem meets the investigatory level in the future Highways will reassess and take any action necessary.

The water running along the road on the Ireby towards Birkmire road had been reported to the Technical Team at Highways to establish where it is coming from.

The following matters were reported

Road surface breaking up with several pot holes on the Ireby to Uldale Road – Highways are aware of this.

The road surface is breaking up with several potholes on the Daleside to Aughertree road and on the Aughertree to Uldale road

Standing water on the Torpenhow/Ireby road.

# (b) Lengsthman

The Chairman reported that he had contacted Mungrisdale Parish Council who are in the process of preparing a job specification for a lengthsman. Once the specification is ready Mungrisdale PC will share the job spec with this Parish Council.

# 86 DONATION REQUEST

An update had been provided under public participation. Members were asked if they would consider making a donation towards a power washer for maintenance of the school grounds. A request with further information will be submitted for consideration at the next meeting.

# 87 EMERGENCY PLANNING

Cllr Alexander reported that the Northern Fells Group are looking at preparing an emergency plan with the emergency plans of the parishes of the Northern Fells area being linked into the plan. At the present time the Parish Council does not have an emergency plan but are in the process of completing the emergency information sheet requested by Cumbria County Council.

Cllr Perry was requested to enquire at Cumbria County Council how a Parish Emergency Plan would tie into the County Council's Emergency Plan.

The Clerk agreed to submit the forms to the Borough Council.

Cllr Perry reported there are still three vacancies on the Senior Management Team for Cumberland Council and all staff will be transferred over to the new Council via TUPE. The Budget had been agreed with an increase of 4.99% for Cumberland's part of the Council Tax. There would also be a harmonisation of council tax rates over the three areas which would see a further increase. Cllr Perry was asked to enquire why some residents had received letters requesting that Council Tax is paid weekly in the next financial year. Cllr Perry also reported that a road safety review is to be undertaken which will look at 20mph zones in residential areas. It was noted that the parish council would like to see a speed limit implemented in Uldale and a 20mph speed limit implemented in Ireby.
