74/24 MINUTES – MEETING 5 NOVEMBER 2024

75/24 DECLARATIONS OF INTEREST/REQUESTS FOR DISPENSATIONS

76/24 REPORTS

- (a) The newsletter for the Cockermouth/Keswick area had been circulated by email.
- (b) Cumberland Councillor Cllr J. Perry reported that she would be attending a meeting in Penrith for an update on Community Policing. Cllr Perry advised that the Lakes to Sea Community Panel Active Travel Event will be held on Friday 17th January 1pm to 3pm at Cockermouth Rugby Club. Cllr Perry also reported that the Local Government Boundary Commission consultation on Cumberland Council wards and the consultation to Shape the Future of Bus Services in Cumberland are still open. Cllr Perry advised that the Cumberland Council Bus Infrastructure Officer will be attending the Active Travel meeting and agreed to raise that the Parish Council would like to see the 73-bus service reinstated to come through both villages.

A member of the public asked whether the Parish Council would be supportive of the introduction of a street market in Ireby. The Chair responded that the Parish Council would be in support of an initiative such as this should it arise in the future.

81/24 HIGHWAYS/HIGHWAY MAINTENANCE

The following matters were discussed:

The Chair recorded his thanks to Cumberland Council for providing a thorough service gritting the roads during the inclement weather experienced the previous week.

A request had been received for a grit bin to the sited in the Stanthwaite area.

Cllr Cockburn reported that Highways had attended the drain at High Ireby but were still unable to remove the grid and advised they would return at the end of the week.

Following the report submitted on the HIAMS that there are numerous pot holes on Snittlegarth Lonning Highways had responded that the Network Management Team are currently in discussion with the Legal and Traffic team regarding the Traffic Regulation Order for this road. Cllr Normington agreed to raise this at the Active Travel meeting on Friday.

Cllr G. Moore had raised the issues on the Daleside to Aughertree road with Cllr J. Perry.

82/24 PARISH PLAN/COMMUNITY ENGAGEMENT

Cllr P. Normington brought Members up to date and reported that it had been decided not to go ahead with the Community Engagement weekend planned for the end of February as an objection had been received that a member of the public had been left out of the planning stage.

It was agreed to distribute a flyer to residents to ask if they would like to be involved in the development of a community plan for Ireby and Uldale.

Residents can express their interest by sending an email with their contact details to CLP@ireby-and-uldale.org.uk; or talking with one of your Parish Councillors; or writing to the Parish Council Clerk, Mrs J Rae, 23 Chapel Meadows, Bothel, CA7 2AB before 30th April 2025. The Parish Council will then arrange for a public meeting to be held for all interested parties to explore the next step and the setting up of an independent Steering Group.

83/24 WEBSITE/INTERNET DOMAIN/USE OF PERSONAL EMAIL ADDRESSES

Cllr P. Normington updated Members following his attendance at the presentation by Active Councils and CALC on 13 November. Cllr Normington had circulated the information provided by Active Councils to Members. Members discussed the proposal and resolved to go ahead despite being too late to take advantage of the initial offer of funding of £100 towards the first year. Cllr Normington agreed to contact Active Councils to request a new proposal be drawn up based on registering a .gov domain name and website hosting and support. Cllr Normington offered to assist in setting up councillor email addresses.

84/24 TREE MAINTENANCE

The correspondence received from Cumberland Council had been circulated prior to the meeting. The correspondence advised that work is required to tree(s) on parish land located on the C2059 land lying to the south east of Ireby and states that the trees are growing in such a way as to endanger or obstruct the passage of pedestrians and/or vehicles. The work required – remove all category 3 and 4 ash trees and monitor the remaining trees annually for further decline from Ash dieback. Cumberland Council require the work to remove the obstruction to be completed within 12 months. RESOLVED to obtain estimate(s) for the necessary work.

85/24 LOCAL GOVERNMENT BOUNDARY COMMISSION REVIEW OF CUMBERLAND COUNCIL WARDS

The Local Government Boundary Commission for England is inviting proposals for new council wards and ward boundaries for Cumberland Council. The electoral review will recommend new electoral arrangements for Cumberland Council and will propose: the total number of councillors elected to the council in the future; the number of wards; the number of councillors representing each ward; ward boundaries; and the names of wards. The public consultation is inviting views from individuals and organisations across Cumberland on where they think new ward boundaries should be drawn. The Boundary Commission is recommending that 55 councillors should be elected to Cumberland Council in the future. This is 9 more than the current number of councillors. Proposals are invited to help draw up a pattern of wards to accommodate 55 councillors. The consultation will close on 24 February 2025. Draft recommendations will be published in July 2025.
