### 64 APOLOGIES FOR ABSENCE

### 65 MINUTES – 1 NOVEMBER 2022

The minutes of the meeting held on 1<sup>st</sup> November, 2022 were agreed as a correct record and were signed by the Chair.

### 69 MATTERS ARISING FROM THE MEETING ON 1 NOVEMBER 2022

Crosby House Barn – Members noted that a replacement door had been fitted on Crosby House Barn.

Cllr Moore reported that he had cut back the ivy on the cherry tree at the top of the whent in Ireby.

Accompanied by Cllrs Moore and Payne CWB Forestry had carried out a site inspection of the trees on the parish land opposite Whinney Tip. Two quotations had been received for the necessary works. Quotation 1 to carry out the urgent work required at £490.00. Members had been consulted and as the work was considered urgent the contractor had been instructed to carry out the work immediately. Quotation 2 will be considered later in the meeting.

#### 72 HIGHWAYS/HIGHWAY MAINTENANCE

(a) Highway issues in the Parish

Cllr Perry reported she had been contacted by a resident regarding the Uldale to Castle Inn road which is not on the gritting route. Cllr Perry advised she had contacted Cllr Rollo the portfolio holder for the Environment and Highways at Cumberland Council with a request that this road is added to the gritting route. Cllr Cockburn reported that street light no 3 at Binsey Farm, High Ireby previously reported was still not working.

Clir Cockburn reported that the gravel at the bottom of Snittlegarth lonning had not been cleared away.

Cllr Payne reported that following the burst water main on the main street in Ireby a large port hole is now present in the middle of the road.

The Clerk reported that Highways had requested further information following the request for the gully wagon to clean the drains in the parish.

(b) Lengsthman

Members considered further whether it would be feasible to employ a lengthsman. The feedback from Mungrisdale and Above Derwent Parish Councils was discussed. It was agreed that the Chairman would contact Mungrisdale PC to request a copy of the job description. The costs involved with employing a lengthsman would also have to be considered.

### 73 TREE MAINTENANCE/SAFETY INSPECTIONS

Cllrs Moore and Payne had attended a site inspection of the parish land opposite Whinney Tip with CWB Forestry. Two quotations for the necessary had been received. The contractor had been instructed to carry out the urgent works detailed in quotation 1 immediately. Members now considered the works detailed in quotation 2 at a cost of £880.00. RESOLVED that the contractor be instructed to carry out the work detailed in quotation 2.

## 74 DONATION REQUEST – GROUNDS MAINTENANCE EQUIPMENT

This item had been discussed under public participation. It was now suggested that the parish council consider making a donation towards the insurance to cover any volunteers undertaking work in the parish. The parish member in attendance agreed to provide further information and costings for the insurance and would submit an application to be considered at the next meeting.
