44 APOLOGIES FOR ABSENCE

An apology for absence was received from K. Bridges. The reason for absence was noted and accepted.

45 MINUTES – MEETING 7 SEPTEMBER 2021

The minutes of the meeting held on 7th September, 2021 were agreed as a correct record and were signed by the Chairman.

46 DECLARATIONS OF INTEREST

F. Payne declared an interest in item 11 on the agenda (ACV nomination) and E. Alexander declared an interest in item 7 (b) on the agenda (WI Hall).

47 POLICE REPORT

The newsletter for the Wigton/Silloth/Aspatria area had been circulated prior to the meeting. Members noted that the PCSO is regularly attending auction marts across the area to engage with farming and rural communities.

48 PUBLIC PARTICIPATION

One member of the public was in attendance and updated Members regarding the nomination to list the premises Emily's Black Lion as an asset of community value. Members were advised that the Borough Council had accepted the nomination. Members were also updated on the recent incidents relating to the use and abuse of the noticeboard in Ireby.

49 MATTERS ARISING FROM THE MEETING 7 SEPTEMBER 2021

Land at Suncroft – The Borough Council had confirmed this matter had now been resolved.

Waste Bin, Uldale – The Borough Council had advised that they had reviewed the reporting system for the area. In the last 3 months there had been 3 reports for dog mess and 2 reports of littering. To allow resources to be prioritised in the areas most in need residents are encouraged to report issues using the Myallerdale system.

Poor Water Supply – Moot Hall, Ireby – United Utilities had completed their work satisfactorily and had provided before and after photographs.

Overgrown hedge at Uldale – Confirmation had been received that the overgrown hedge/overhanging branches had been cut back.

The Information Commissioner's Office had confirmed that the Data Protection fee had been paid and the Certificate renewed.

Crosby House Barn – There had been no developments since the last meeting. The Clerk was requested to pursue this again with the Borough Council.
