## 50 HIGHWAYS

The following matters were raised:

Mud on the Ireby to Torpenhow road near the Ireby junction Mud on the road on the Ireby to Ruthwaite road where the road narrows at Ireby. With the current freezing weather conditions this is causing a hazard.

The Ireby to Torpenhow road is still flooding. Flooding still occurring on the Ireby to High Ireby road

Blocked culvert on the Aughertree to Ireby road between Aughertree road end towards the Guards lonning end - The Chairman reported that Highways had carried out some work but the problem had not been completely resolved.

Cllr Bridges reported that some of the pot holes on the Ireby to Uldale road recently repaired had now washed out after three weeks.

Grit bins need replenished

Cllr Bowness reported that the implementation of a 50mph speed limit on the A595 through Bothel had been agreed by Cumbria County Council. Works are also to be undertaken to improve the Greyhound, Bothel/Torpenhow junction.

# 51 GRASS CUTTING CONTRACT

Members noted that the grass cutting contract is due to be renewed this year. It was agreed that tenders would be invited for cutting the areas in Uldale and Ruthwaite with the conditions of the contract as per the previous. The tenders received will be considered at the next meeting and a contractor appointed.

## 53 ALLERDALE BOROUGH COUNCIL BUDGET CONSULTATION

The Borough Council had published its Budget Consultation for 2021/22. The consultation is online until 15<sup>th</sup> January and provides an opportunity to comment on the changes to Council Tax for 2021/22. The Borough Council is proposing to increase their part of the Council Tax by £5 per year on a Band D property or by 1.99%. Members were encouraged to complete the online consultation.
